

## Gist of the Charge:

I, A person, resident in India acquiring Foreign Exchange from persons other than authorised dealers in Foreign Exchange without the permission from the Reserve Bank of India.

I, A person, resident in India made deposit of Foreign Exchange in Barclays Bank thereby lending the said Foreign Exchange to a person not being an authorised dealer in Foreign Exchange without the permission of RBI.

Making payments without exemptions from RBI to a company registered in a foreign country, viz., a person, resident of outside India, thereby contravene the provisions.

Failed to offer the amount involved for sale to an authorised dealer in Foreign Exchange within three months from the date of becoming owner.

A person resident in India, transferred certain amount to a bank Ireland, etc., person other than the authorised dealers in foreign exchange without permission from RBI - Making payments to persons resident outside India without the exemption from the RBI.

#### Gist of the Case:

The Enforcement Directorate filed the complaint that TTV Dhinakaran a person resident in India other than an authorized dealer in foreign exchange had contravened the provisions of Sec. 8(1), by otherwise acquiring foreign exchange from persons other than authorized dealer in foreign exchange without previous

permission of the Reserve Bank of India, by depositing the said foreign exchange in the current account of M/s. Dipper Investments thereby lending the said foreign exchange to a person not being authorized dealer, making payments without exemption of the Reserve Bank of India, to the credit of M/s. Dipper Investments, by failing to offer the said amount for sale or cause it to be offered for sale to an authorized dealer in foreign exchange, by otherwise transferring without the previous general permission of the Reserve Bank of India, to person other than authorized dealers in foreign exchange, by making the aforesaid payments without exemption from Reserve Bank of India to persons resident outside. India.

E.O.CC No. 84/2001 – Under Section 8(1), 9(1)(A) and 56 (1)(i) of the Foreign Exchange Regulation Act, 1973, read with Sec. 49(3) and (4) of Foreign Exchange Management Act, 1999.

Gist of Charges: A person, resident in India, acquiring the foreign exchange from persons not being authorised dealers in foreign exchange without permission of the Reserve Bank of India.

A person, resident in India, made payments to the credit of a person resident outside without exemption from the Reserve Bank of India.

#### Gist of the Case:

The Enforcement Directorate filed the complaint that TTV Dhinakaran a person resident in India other than an authorized dealer in foreign exchange had contravened the provisions of Sec. 8(1), by otherwise acquiring foreign exchange from persons other than authorized dealer in foreign exchange without previous

		permission of the Reserve Bank of India, had also contravened by making payments during 1994-95 to the credit of a person resident outside India without the general or special exemption of the Reserve Bank of India.

by TTV Dhinakaran to discharge. By order dated 01.07.2005, the Learned Addl. Chief Metropolitan Magistrate passed an order discharging TTV Dhinakaran in all the three cases. Being aggrieved against that the Enforcement Directorate filed Crl. Rev. No. 811, 812, and 813 of 2005. By order dated 03.12.2010, the Hon'ble High Court dismissed all the three Revision Petitions by confirming the order of Discharge. Being aggrieved against that the Enforcement Directorate filed Criminal Appeal Nos. 1843, 1844 and 1845 of 2012 before the Hon'ble Supreme Court of India and the same is pending.

(2) PS Crime Branch, New Delhi / Special Judge VII, PC Act cases of ACB, GNCTD, Central District, THC, Delhi - FIR No. 56/2017 –

Therefore, this case was registered.

Therefore, he made a complaint against Senthil, Comedy Actor and TTV Dhinakaran. (4) Annadanapatti Police Station, Salem City. -FIR No. 529/2017, dt. 29.9.2017 Offences Under Sec. 143, 120(b), 124(a), 153, 500, 504 and 506/2 of Indian Penal Code, 1860. Gist: One Saravanan made a complaint making allegations that certain person are distributing pamphlets in which statement have been made by instigating people to create problem against the State and Central Government and also making allegations against the Govt. Of Tamil Nadu, Chief Minister and Prime Minister. The said allegations was made against the named person, that TTV Dhinakaran was included as 14<sup>th</sup> Accused. 
