In the letter first read above, the Government have approved the estimate of vacancies for the post of Deputy Superintendent of Police (Class.II, Category.I of Tamil Nadu Police Service) for the year 2020-2021, to be filled up by direct recruitment and by recruitment by transfer as 'Nil' and also approved 'Nil' panel for the said post for the year 2020-2021, in the Government letter second read above.

2. The Government in the letter third read above, among others, have approved the estimate of vacancies for the post of Deputy Superintendent of Police (Category.I) in the Tamil Nadu Police Service to be filled up by recruitment by transfer for the year 2021-2022, as '91'.

3. In his letter fourth read above, the Director General of Police has sent proposal for drawal of temporary panel of Inspectors of Police (Taluk) fit for appointment by recruitment by transfer as Deputy Superintendents of Police (Category.I) for the year 2021-2022.

4. The Government have carefully examined the proposal of the Director General of Police and have decided to draw the temporary panel of Inspectors of Police fit for appointment by recruitment by transfer as Deputy Superintendents of Police (Category.I) for the year 2021-2022 by including 91 Inspectors of Police and also to relax rule 4(G) of the Special Rules for the Tamil Nadu Police Service regarding the condition of completion of pre-promotion course of four weeks conducted by the Tamil Nadu Police Academy, Chennai in favour of the 23 Inspectors of Police (Taluk), since they have not completed the course on the crucial date i.e., 01.06.2021.

5. Accordingly, in exercise of the powers conferred by section 58 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016, the Governor of Tamil Nadu hereby relaxes rule 4(G) of the Special Rules for the Tamil Nadu Police Service in favour of the 23 Inspectors of Police (Taluk) mentioned below at Sl.Nos.15, 17, 42, 49, 56, 60, 64, 65, 77, 78, 79, 80, 81, 82, 83, 84, 85, 86, 87, 88, 89, 90, 91 and approve the temporary panel of Inspectors of Police fit for appointment by recruitment by transfer as Deputy Superintendents of Police (Category.I) for the year 2021-2022 by including the following 91 Inspectors of Police.
