Ramajayam, 10th Cross, Thillai Nagar, Trichy presented herself in the Police station and lodged a complaint, the details of which is as follows:-

My husband Shri K.N. Ramajayam, is the brother of Shri K.N. Nehru, Ex Minister of Tamil Nadu for Transport Department. We are residing at the address C-74, 10th Cross, Thillai Nagar. Usually, my husband goes for walking every day morning at about 0500 to 05.15 hrs., and walks usually at Thillai Nagar Railway Station Platform and adjacent place. In the same way, today i.e., 29.03.2012 morning, he went wearing blue color Lungi and white colour half sleeve shirt. He was holding the mobile numbers 8220635233 and 9710217340. Since, he did not return to the house till 08.00 hrs., when I contacted my husband in his mobile, it

Was kept switched off. When I contacted after some time, I got the ringtone in the mobile. Since I called continuously, during 4th or 5th time, some one took the mobile and spoke in a hard voice. He asked me as to who I was and disconnected the connection. Later at 0840 hrs, they have contacted one Gopalakrishnan of Care College Canteen from my husband's mobile number and asked the mobile number of my husband's brother Shri K.N. Nehru. Again, they contacted Anuradha of KVK, Pulutheri at about 0830 hrs., and enquired in the same way. It is suspected that my husband could have been kidnapped by some miscreants and anti-social elements. It is humbly requested to trace him and hand over by not causing any kind of danger to him.

I am working as Village Administrative Officer of Thimmaraya Samuthiram. Today i.e., 29.03.2012 morning, while I was on duty, at about 1015 hrs, based on the information received by me, it is learnt that a dead body was found with hands and legs tied with string in my jurisdiction at Kallanai Road, opposite to Ponni Delta building in Kaveri river bed area. In this connection, I alongwith my Assistant Shri Jayaram visited the place of occurrence at about 1030 hrs., and it was found that the hands and legs of the dead body were tied with string and wrapped with kakki colour plastic tape. The mouth was stuffed with brown colour cloth. The dead body was found with wearing a white colour half sleeve shirt and light purple colour lungi with white checked around the hip. The dead body was also covered with one brown colour flower designed blanket. In this connection, when enquired at the place of occurrence, it was informed that it seems to be Shri K.N. Ramajayam, who is the younger brother of Shri K.N. Nehru, Ex-Minister of DMK. Immediately, In informed the matter to Srirangam P.S. and lodged a complaint at about 11.00 hrs. I request to take necessary action on the same.
