## PROMOTION AND POSTING ORDER

Sub: Establishment – Promotions from the 'C' List of Sub-Inspectors of Police (Taluk) fit for promotion as Inspectors of Police (Taluk) drawn for the year (2018 – 2019) – Allotment Orders – Issued.

Ref : Proceedings of the Director General of Police, Tamil Nadu in C. No. 52543/NGB. 1(1)/2018, dated 28.06.2019.

The Sub-Inspectors of Police (Taluk) mentioned in the Annexure are promoted as Inspectors of Police (Taluk) and allotted to the Zones/Cities/Special Units as noted against them with immediate effect.

- 2. The Unit officers concerned are requested to serve this order to the individuals immediately and ensure that they are relieved with instructions to report before the respective Unit Officers for further postings as Inspectors of Police (Cate.1).
- 3. Before issuing Promotion Orders, they have to ensure that the Sub-Inspectors of Police (Cate.1), concerned against whom specific charges under rule 3(b) of TNPSS (D&A) Rules are framed, served and pending disposal (or) who are charge sheeted in a criminal case and case is pending trial, and those who have earned current punishments after their inclusion in the 'C' list **should not be promoted**, notwithstanding the fact that their names have been included in the 'C' list and their promotion in such cases should be deferred till the disposal of disciplinary proceedings / Criminal case / TDP enquiry/completion of current punishment. The same procedure should be adopted in cases, where such formulated charges are stayed in Tribunal / Court.
- 4. In all such cases, where promotion is deferred for the above said reasons, necessary report should be sent to Chief Office, immediately by the respective Unit Officers.

- 5. The Sub-Inspectors of Police (Taluk) so promoted should be relieved forthwith and a compliance report should be sent to Chief Office immediately. Similarly, the dates of their relief, dates of their joining as Inspector of Police and place of posting as Inspectors of Police along with their service particulars should also be sent to Chief Office immediately on assumption of charge to make necessary entries in Chief Office records.
  - 6. Receipt of this order should be acknowledged immediately.
