PETITION FOR BAIL Under Sec. 439 of Cr.P.C.

PRAYER :-For bail in crime.no.377 of 2021 onthe file of the respondent police.

ORDER: The Court made the following order:-

The petitioner/A2, who was arrested on 24.07.2021 for the offences punishable under Sections 143, 153A, 295A, 505(2), 506(i), 269 I.P.C and Section 3 of Epidemic Disease Act, 1987, in Crime No.377 of 2021 on the file of the respondent police, seeks bail.

- 2. The case of the prosecution is that this petitioner has made some derogatory statements against the religious and political leaders during a meeting which was held on 18.07.2021.
- 3. The learned Government Advocate (Crl. Side) appearing for the respondent police and Mrs. Victoria Gowri, learned counsel appearing for the defacto complainant have strongly opposed to grant bail to the petitioner on the ground that the petitioner has spoken unparliamentary statements against the religious and political leaders and if he is released on bail, it would cause distress among the people who are living peacefully in Kanyakumari District.
- 4.Mr.T.Lajapathi Roy, the learned Counsel fairly submits that the petitioner ought to have avoided certain unnecessary remarks in his public speech and he has also advised the petitioner to avoid https://www.hat.to.ii/pags in the future. The petitioner is also ready to file an



affidavit of undertaking that he will not make such statements as against the religious and political leaders in future. The learned counsel has also submitted that the petitioner is having heart problem and he is taking treatment for the said illness and he is also prepared to stay away from Kanyakumari District.

- 5.Considering the rival submissions, the period of incarceration and the fact that the petitioner is ready to file an undertaking affidavit that the he will not make such unparliamentary words in future, this Court is inclined to grant bail to the petitioner.
- 6. Accordingly, this Criminal Original Petition is allowed and the petitioner is ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate No.I, Kuzhithurai, Kanyakumari District and on further conditions that:
- [a] the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or bank pass book to ensure their identity.
- [b] the petitioner shall stay at Trichy and report before the Thillai Nagar Police Station daily at 10.30 a.m. until further orders.
- [c] the petitioner shall also file an undertaking affidavit that he will not make such derogatory or unparliamentary words as against the religious and political leaders in future.
- [d] the petitioner shall not abscond either during investigation or trial.
- [e] the petitioner shall not tamper with the evidence or witness either during investigation or trial.
- [f] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].
- [g] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
